# SUPPORTING SMALL BUSINESS AND STRENGTHENING INDUSTRY



Recently, I had the pleasure of announcing our government's investment of nearly \$4.5 million for ventureLAB's Hardware Catalyst Initiative (HCI) helping Canada's only incubator for semiconductor innovation grow right here in Markham. This investment is important not only for ventureLAB, Markham and York Region, but for Canada's economy. Investing in Markham's thriving technology industry supports its continued growth as a technology capital for the country. This investment will encourage continued innovation in Al, Quantum, and Advanced Manufacturing and will help grow Canadian business into global supply chains— and Canadian entrepreneurs into alobal leaders.

Our government's agreements with Visa and Mastercard to lower credit card transaction fees for small businesses were finalized in December. The agreements will help more than 90% of credit card – accepting businesses in Canada qualify for lower rates and see their interchange fees reduced by up to 27%. These reductions are expected to collectively save eligible small businesses approximately \$1 billion over five years. This will help small businesses combat their rising costs, helping them succeed. The agreements also protect reward points offered to Canadian consumers by Canada's large banks.

## CANADIAN DENTAL CARE PLAN

The Canadian Dental Care Plan (CDCP) will help up to 9 million uninsured Canadians access preventive care and treatment by helping cover the cost of oral health care services like cleaning, polishing, x-rays, fillings, removable dentures, and root canal treatments. The CDCP application process will be launched in phases, by age. Eligible individuals will receive a letter from Service Canada inviting them to apply, with instructions on how to apply by telephone. You can learn more about the CDCP by visiting Canada.ca/dental.

To be eligible, Canadian residents must:

- not have access to any private dental benefits, including through employers, pensions or privately purchased plans;
- have an adjusted family net income of less than \$90,000;
- be a Canadian resident for tax purposes; and have filed their tax return in the previous year.

In May 2024, applications will open for eligible seniors 65 to 69. Persons with a valid Disability Tax Credit certificate and children under the age of 18 will be able to apply online as of June 2024. All remaining eligible Canadians will be able to apply in 2025.
