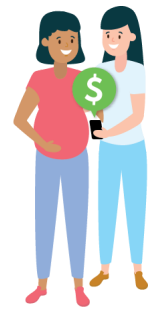

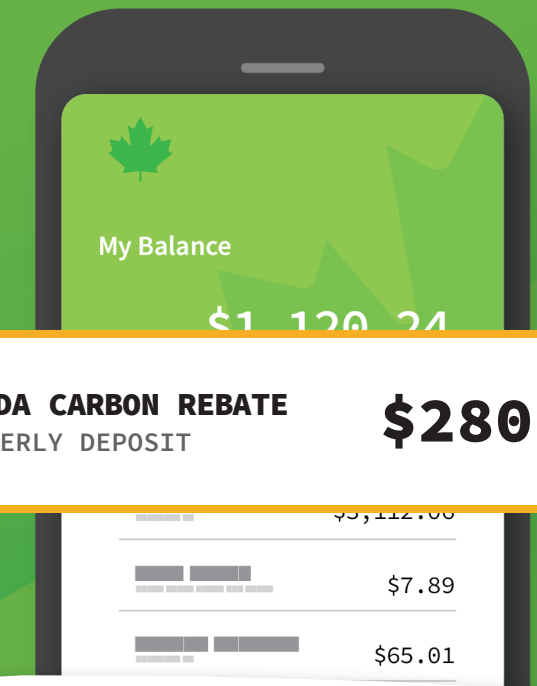

# How Carbon Pricing and the Canada Carbon Rebate works

Here's how carbon pricing works: We make big polluters pay for emitting carbon. We put that money in your pocket.

Money collected through pricing carbon emissions gets paid out to Canadians every three months through the Canada Carbon Rebate. It's automatic – and everyone gets it, no matter how much money you make. It's proven that eight out of ten Canadians get more money back through the Canada Carbon Rebate than they pay.

By making it expensive to pollute, carbon pricing encourages big polluters to find greener alternatives.

We are all fighting climate change together—and the Canada Carbon Rebate helps make it more affordable to do so.

## Frequently Asked Questions

### Why didn't I get the rebate?

As long as you've filed your taxes, you'll automatically get the rebate. One person in your family will receive it on behalf of your household.

### How do I get the Canada Carbon Rebate?

The Canada Carbon Rebate is sent out automatically every three months by direct deposit or cheque – all you need to do is file your taxes.

### I don't see the rebate in my bank account.

It's there, but it might not be obvious on your bank statement - each bank titles the payment differently.

### Who is eligible to receive the Canada Carbon Rebate?

The Canada Carbon Rebate is applicable to everyone that files their taxes – it doesn't matter how much you make.

### I've heard the Canada Carbon Rebate costs me money – is that true?

Not true! The vast majority of Canadians actually profit off of the Canada Carbon Rebate, getting more money back each year than they've spent on the price on pollution.

### Does pollution pricing actually work? Does it help fight climate change?

It works! Canada's carbon emissions – what causes climate change – are going down, thanks to a whole range of actions our government has taken. This includes making it expensive to pollute, while putting money in your pocket through the Canada Carbon Rebate.
